Executive Summary: The property owner has requested to amend the Town of Cary Official Zoning Map by amending a portion of the previously approved Regency Park Planned Development District (PDD) to add Parking Lot as a principal use to the list of permitted land uses, with exclusion of Use Specific Standards included in LDO Section 5.2.3(J)(1).

Planning and Zoning Board Recommendation: The recommendation will be provided to Town Council following the P&Z Board meeting.

Note: The purpose of the rezoning is to determine whether or not the land uses and densities allowed in the proposed zoning district are appropriate for the site. Technical design standards of the Land
