## Speaker: Mary Beerman

**Executive Summary:** To amend the Town of Cary Official Zoning Map by applying initial Town of Cary zoning to two parcels totaling 21.03 acres located at 1304 Batchelor Road and 4309 Pine Rail Lane. The property is currently in the Wake County Residential-40 Watershed (R-40W) zoning district. The property owner proposes to rezone the property to Town of Cary Residential-40 Conditional Use (R-40-CU), Conservation Residential Overlay District (CROD) and Watershed Protection Overlay District (Jordan Lake Watershed), with zoning conditions that include limiting land uses to detached dwellings.

There is an associated Owner-Initiated Annexation Petition – **16-A-03**. This rezoning has an associated Consistency and Reasonableness Statement.

**Planning and Zoning Board Recommendation:** The Planning and Zoning Board recommended approval by a vote of 8-0.

### Proposed Council Action: Council may take action.

Note: The purpose of the rezoning is to determine whether or not the land uses and densities allowed in the proposed zoning district are appropriate for the site. Technical design standards of the Land Development Ordinance are addressed during review of the site or subdivision plan.
