## Silverton (Parcel S) PDD Amendment 16-REZ-04 (PL16-066b)

**Executive Summary:** To amend the Town of Cary Official Zoning Map by amending a 4.31-acre (Parcel S) portion of the previously approved Silverton Planned Development District (PDD) by changing the use designation from Active Recreation (Swim and Tennis Club) to Commercial, Indoor/Outdoor Recreation. Conditions offered by the applicant would limit uses to those currently allowed on the property, but would allow the existing pool to be enclosed. No change to the width of the existing 50-foot buffer along the southern property line of the subject property is proposed, however, the performance standard of the buffer has been proposed to meet a Type-B (semi-opaque) standard.

This rezoning has an associated Consistency and Reasonableness Statement.

**Planning and Zoning Board Recommendation:** The Planning and Zoning Board voted 9-0 to forward the request to council with a recommendation for approval.

Proposed Council Action: Council may take action.

NOTE: The purpose of the rezoning is to determine whether or not the land uses and densities allowed in the proposed zoning district are appropriate for the site. Technical design standards of the Land Development Ordinance are addressed during review of the site or subdivision plan.

### **PROJECT SUMMARY**

The Silverton PDD was established in 1985. At that time the subject property was labeled for "Active Recreation." Portions of the PDD were amended in 1992 and the designation for the subject property was changed to "Swim & Tennis Club."

The applicant proposes to enclose the existing swimming pool on the parcel. Since this would result in year-round activity on the site that is not typical of neighborhood recreation sites, a rezoning is required to more accurately reflect the existing and proposed use and apply the designation of Commercial, Indoor/Outdoor Recreation. The applicant has proposed to limit the uses on the site to the existing uses. The existing facilities on the property are open to the public (through memberships) and are not limited to residents of the adjacent neighborhood.
