Executive Summary: The applicant's request is to amend the Comprehensive Plan for approximately 5.49 acres located in the northeast corner of the intersection of Wellingborough Drive and Tryon Road. The request is to change the existing land use designation of the site from Office and Institutional (OFC/INS) to a proposed land use designation of Medium Density Residential (MDR). Approximately 3.65 acres of the total 5.49 acres lies within the Wellington Park Community Activity Center. The applicant proposes to extend the boundary of the Activity Center to include the remaining 1.84 acres such that all of the 5.49 acres will be part of the Wellington Park Community Activity Center.

There is a rezoning application (15-REZ-14) associated with this case.

Planning and Zoning Board Recommendation: The Planning and Zoning Board voted 9-0 to forward the CPA request to Town Council with a favorable recommendation.

Proposed Council Action: Council may take action.
