## **Third-Party Inspections Procedure**

\*\* This form was last revised on 07.08.2021 \*\*

NCGS§ 160D-1106 states that the form approved by the North Carolina Building Code Council shall be used when a licensed architect or licensed engineer performs a component or element inspection. A copy of the form is attached.

- Third-party inspections are not a substitute for Town of Cary inspections and therefore must have prior approval before acceptance.
- Work shall not be done beyond the point indicated in each successive inspection without first obtaining the approval of the code enforcement official or the approval and acknowledgement per NCGS 160D-1106.
- These requirements do <u>not</u> apply to the required Special Inspections and tests listed in chapter 17 of the NC Building Code.

#### **Form Submission:**

• Inspections must still be scheduled by the permit holder and inspectors must do a site visit to verify the component or element of the Third-party inspection.

The form must be submitted to the code official no later than upon the Code Official's arrival on the project site on the day of the scheduled inspection. An electronic (pdf) copy of the completed form is strongly preferred.

- If you are unsure which Code Official is assigned to your project:
  - Provide a paper copy of this completed form to the Code Official on the project site at the time of inspection.
