# INTRODUCTION



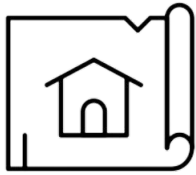
Cary, North Carolina is pleased to present the FY 2023 Building Code Enforcement Report. Per N.C. General Statute 160D-1102(c), every local government is required to publish an annual financial report by October 1 showing how building code enforcement fees were spent. Cary's approach to meeting this requirement is to report this information in this document as well as the FY 2023 Annual Comprehensive Financial Report<sup>(1)</sup> (ACFR).

State law requires that these fees are used for the support, administration, and implementation of the building code enforcement program. For FY 2023, all revenues earned by this program were used for Cary's building code enforcement program as expenditures exceed the revenues.
