Instructions

All petitions for Town funded water and/or sewer extensions shall sufficiently satisfy the following criteria.

- a) If the property deed is registered in the name of one owner or spouse, then only that person's signature is required for the petition. If the property deed is registered in the name of multiple parties, then all owners' signatures are required as they are recorded on the property deed.
- b) Property owners who own more than one property adjacent to proposed utility extensions must sign the petition for each of their properties within the project area.

We the undersigned property owners of the **Holly Brook Subdivision Phase 1 and Phase 2** do hereby request the extension of water and sewer utility service to our property in accordance with the Town of Cary Policy Statement Number 23 as adopted by Council on October 30, 2014.

By signing this form, we the residents understand and agree to the following terms:

1. To comply with the provisions of Policy Statement Number 23, the Holly Brook HOA will be responsible for the payment of development fees in accordance with the Statement of General Understanding.
2. Some development fees and connection fees will be waived per the Statement of General Understanding.
3. The Town of Cary will utilize the square footage estimates as determined by Wake County for property valuation, and we have reviewed the Wake County data in the attached table.
4. The Town of Cary reserves the right to withdraw support for utility extension projects in cases where applicants fail to meet the development fee payments as outlined in Policy Statement Number 23.
5. We will be required to obtain all necessary plumbing permits from the Town of Cary, necessary for establishing our private service lines and that we will be required to request a water meter if initiating water service.
6. We will be solely responsible for establishing the residential service connections from our home to the public right-of-way or utility easement boundary, which at a minimum will involve hiring a plumber to install the service piping.
7. We will be responsible for activating a utility billing account with the Town of Cary prior to utilizing water and sewer utility service.
8. We grant permission to the Town of Cary to enter upon our property to conduct field surveys, examinations, appraisals, and other necessary investigations to develop a design for the requested water and sewer utilities.
9. We agree to dedicate easements for the water and sewer lines that cross our property, provide utility service to our property, and may serve other properties.
